II. EXECUTIVE SUMMARY

Task Force Meetings

Twice annually, a task force of representatives comprised of mobilehome owners, mobilehome park (MP) operators, local enforcement agencies (LEAs), and the California Legislature is convened to provide input to the California Department of Housing and Community Development's (HCD's) Mobilehome Park Maintenance (MPM) inspection program. Your valuable input helps HCD identify goals and priorities. HCD appreciates member participation and the valuable feedback received will support improvements to MPM operations.

MPM Inspections

HCD is committed to protecting the health and safety of MP owners and residents and conducts MPM inspections of MPs to ensure compliance with the applicable laws and regulations. MPM inspections include the MP's common areas, buildings, equipment, and utility systems, as well as lots and the exteriors of every manufactured home and mobilehome (MH) within the MP.

Pursuant to the Mobilehome Parks Act, Health and Safety Code section 18200 et seq., HCD is required to enter and inspect mobilehome parks (MPs) with a goal of inspecting at least five (5) percent of MPs per year that fall under HCD's enforcement responsibility, which is currently equivalent to 183 MPs.

Common Violations

MPM violations are separated into two categories: **park violations** and **resident violations**. The following represents the reporting period of **January 1, 2023, through December 31, 2023**.

The most common ***park violations*** in the reporting period included:

- Exposed live electrical parts
- Gas meters not supported
- Electrical not approved for wet location

The most common ***resident violations*** in the reporting period included:

- Accumulation of garbage, rubbish, or other combustible material
- Appliances outside
- No handrails on stairs

Breakdown of violations identified in the reporting period:

- **4,102 total resident violations**
 - 3,374 corrected and 728 uncorrected
- **1,529 total park violations**
 - 1,259 corrected and 270 uncorrected

Active Park Workload

HCD continues to maintain enforcement responsibility for 82 percent of MPs and approximately 76 percent of MP lots across the state.

MP PTO Suspensions for 2023

As of December 31, 2023, there were 36 MPs with a suspended permit to operate (PTO), compared to 37 MPs in the 2022 calendar year (CY).

III. PROGRAM ACTIVITY

Overview

Between January 1, 2023, and December 31, 2023, HCD inspected 195, or approximately 5.3 percent of MPs, containing 6,493 MH lots.

MPM Inspections Carried Over From 2023

There are 33 MPM inspections initiated in 2023 that will continue into 2024.

IV. REVENUE AND EXPENDITURES




Figure 1: Revenue and expenditures for the reporting period

Fees Collected and Expended

Program expenditures include all inspection and administrative activities, such as:

- Responding to telephone calls from residents and MP owners/operators
- Data entry
- Preparation of mailings, notices, and violations
- Posting of notices within MPs
- Corresponding with MP owners, managers, and/or residents
- General administrative tasks

V. OPERATIONAL CHANGES AND UPDATES

MP Program News

HCD's Division of Codes and Standards (Division) Field Operations was funded for 54 District Representatives (DRs) and 9 Codes and Standards Administrators (CSAs) during the reporting period. DR vacancies fluctuated throughout the period; however, the Division's Field Operations maintains a very low vacancy rate at or below 7 percent. The Division's Field Operations received approval for an additional 10 positions that are currently under recruitment for various functions within program areas.

Current Local Enforcement Agencies (LEAs)

There were 56 active LEAs enforcing the Mobilehome Parks Act and Special Occupancy Parks Act within their respective jurisdictions during the reporting period.

LEA Assumptions

There were no LEAs that assumed enforcement responsibility during the reporting period.

LEA Returns

The following cities returned enforcement responsibility to HCD during the reporting period:

- City of Calistoga returned enforcement responsibility in April 2023. This included 4 parks with a total of 555 MH lots.
- City of Big Bear Lake returned enforcement responsibility in June 2023. This included 8 parks with a total of 344 MH lots.

VI. FIELD OPERATIONS

MPM Inspection Criteria for 2024

The following is the criteria for selecting parks for MPM inspections for calendar year (CY) 2024:

- MPs that have had verified health and safety complaints
- MPs that have not had an MPM inspection in the last seven (7) CYs
- MPs that have no permit history within the last CY
